## GENERAL RACING BET-TYPES & DEFINITIONS

<b>All-In</b>	Refers to markets framed before the declaration of Final Field.
<b>Best of Best</b>	Guarantees a dividend of either Top Fluctuation or Best Tote, whichever is greater.
<b>Best Tote</b>	Guarantees a dividend equal to the highest official Win dividend declared by the three Australian Totes.
<b>Box Exotic</b>	These apply to Exactas, Trifectas and First-Fours. For each bet type, if you box your selections together, it means that all combinations are included so that providing any of your selections fill the required positions (i.e, 1 <sup>st</sup> & 2 <sup>nd</sup> for an Exacta, 1 <sup>st</sup> , 2 <sup>nd</sup> & 3 <sup>rd</sup> for a trifecta and 1 <sup>st</sup> , 2 <sup>nd</sup> 3 <sup>rd</sup> & 4 <sup>th</sup> for a first-four.)
<b>Daily Double</b>	A Daily Double requires nominating the winner of two selected races of a meeting.
<b>Dead-Heat</b>	An outcome where two or more competitors are tied for the same finishing position.
<b>Dead-Heat-Rule</b>	In the Case of a <b>Dead-Heat</b> in an event, the dividend will be determined by dividing the total value of the wager (stake plus winnings) by the total number of competitors that have dead-heated.
<b>Deductions</b>	A reduction in the dividend of a fixed odds bet due to the withdrawal of a competitor after the declaration of Final Field.
<b>Exacta</b>	An Exacta requires nominating the 1st and 2nd place-getters in correct order. (See "Box Exotic" definition also. <b>Exotics</b> Refers to Quinella, Exacta, Trifecta, First Four, Quadrella and Daily Double betting.
<b>Final Field</b>	Refers to markets framed after the Final Field has been officially published.
<b>First Four</b>	A First Four requires nominating the 1st, 2nd, 3rd and 4th place-getters in correct order. (See "Box Exotic" definition also.
<b>Fixed Odds</b>	Means the price quoted by betting.club of a specified runner at the time of placing the wager for both Win and Place markets. These odds are fixed at the time the wager is placed.
<b>Flexi Betting</b>	Flexi Betting allows you to specify the amount you would like to wager on a particular exotic combination. You receive a percentage of the total dividend based on the amount invested and the amount of selections taken.
<b>Futures Betting</b>	Otherwise known as All-In betting, these are wagers placed on Future events before the declaration of Final Field.
<b>Head to Head</b>	Requires you to select the runner who will have the highest finishing position of the nominated runners in the Head to Head market.
<b>Jockey Challenge</b>	A wager type where by jockeys nominated in the market are assigned points based on their finishing position. The points are accumulated throughout a meeting and the jockey with the highest amount of points at the completion of the race meeting is declared the winner.
<b>Middle Tote</b>	Guarantees a dividend equal to the second highest official Win dividend declared by the three Australian Totes.

<b>Multi-Bet</b>	A Multi-Bet, otherwise known as an All-Up or Accumulator, is where a series of bets are linked together on different events, and the return of each leg is automatically placed on to the following leg. All legs must be successful for the wager to be won. The odds of each event are multiplied which results in a dividend for each \$1 placed.
<b>Non-Runner</b>	A runner that was included in a field but was officially deemed by stewards to have not taken part in the event.
<b>Place Card</b>	A Place Card requires you to correctly select horses to place in four nominated races.
<b>Protest Payout</b>	The Protest Payout pays up to \$2000 on a Win bet if the selected Horse is placed first past the post but the runner is relegated as a result of a protest.
<b>Quadrella</b>	A Quadrella requires nominating the 1st placed runner in four races of a meeting.
<b>Quinella</b>	A Quinella requires nominating the 1st and 2nd place-getters in any order.
<b>Top Fluctuation</b>	Guarantees a dividend of the top fluctuation of the relevant state Official Price (OP).
<b>Totes</b>	Refers to the three official Totalisators in Australia being NSW Tote (operated by Tabcorp), VIC Tote (operated by Tabcorp) and QLD Tote (or UNI Tab operated by Tattersalls).
<b>Tote+ %</b>	Guarantees a dividend of the tote product plus a bonus percentage of the amount won on the wager.
<b>Tote Guarantees</b>	Guarantees either the fixed odds at the time the wager was placed, or the specified tote product, whichever is greater.
<b>Trifecta</b>	A Trifecta requires nominating the 1st, 2nd and 3rd place-getters in correct order. (See "Box Exotic" definition also.)

## 1. TRANSFERRED, POSTPONED AND ABANDONED MEETINGS

- 1.1. Where a race meeting is transferred from one racecourse to another, all betting rules will apply as if the meeting was not transferred.
- 1.2. If a race meeting is partially postponed or fully postponed, all unsettled wagers on the postponed meeting will be void.
- 1.3. Bets relating to “All-In Betting” or “Future events” where the meeting has been abandoned, transferred or postponed from the original race date, all bets stand until the completion of the event.
- 1.4. All multi-bets impacted by an abandoned or postponed meeting will be recalculated without that event or leg included.

## 2. SCRATCHINGS AND DEDUCTIONS

- 2.1. Deduction and Scratching rules apply to all thoroughbred, greyhound and Harness markets.
- 2.2. If a runner is scratched in an “All-In” market, then all bets are resulted as a loss.
- 2.3. All bets wagered on scratched runners after final field has been declared will be refunded.
- 2.4. In the Case of late scratching’s after the final field has been declared, deductions will apply to all fixed odds bets – (unless otherwise stated).
- 2.5. All fixed odds bets wagered after the official price service has been applied are subject to deductions, and stewards will declare the official portion of deduction.
- 2.6. In the event of the field being reduced in size from 8 or greater to 7 or less runners, betting.club will pay three place dividends on all fixed odds place bets wagered before the field being reduced. Deductions will apply as required.
- 2.7. In the event of the field being reduced in size from 5, 6 or 7 runners to 4 or less runners, betting.club will pay two place dividends on all fixed odds place bets wagered before the field being reduced. Deductions will apply as required.

## 3. FIELD-SIZE RULE

- 3.1. Where there are eight or more runners in a race, a place dividend shall be paid on first, second and third places.
- 3.2. Where there are seven, six or five runners in a race, a place dividend shall be paid on first and second places only.
- 3.3. Where there are four or less runners in a race, betting will be win only.
- 3.4. Where there are late scratching’s and the field size is reduced to 7, 6 or 5 runners in a race, fixed odds dividends will be paid on 1<sup>st</sup> and 2<sup>nd</sup> only.

## 4. DEAD-HEAT RULE

- 4.1. A Dead-Heat is defined as an outcome where two or more competitors are tied for the same finishing position. In the Case of a Dead-Heat, the total value of the wager is divided by the total number of competitors that have Dead-Heated.

## 5. INTERNATIONAL RACING LIMITS

The following limits apply to all International Racing Wagers accepted by betting.club. These limits override any general bet type limits.

- 5.1. Unless otherwise agreed, the maximum payout per client per event will be:
- \$25,000 on any 'Win' bet type on all thoroughbred meetings;
  - \$10,000 on any 'Place' bet type on all thoroughbred meetings;
  - \$10,000 on any winning 'Exotic' bet type on all thoroughbred meetings;
  - \$10,000 on any 'Multi' bet type on all thoroughbred meetings;
  - \$5,000 on any 'Head-to-Head' bet type on all thoroughbred meetings;
  - \$5,000 on any 'Jockey Challenge' bet type on all thoroughbred meetings;
  - \$15,000 on any 'Win' bet type on all greyhound & harness meetings;
  - \$7,000 on any 'Place' bet type on all greyhound & harness meetings;
  - \$5,000 on any 'Exotic' bet type on all greyhound & harness meetings; and
  - \$5,000 on any 'Multi' bet type on all greyhound and harness meetings.

## 6. BETTING LIMITS

### 6.1. Maximum Dividends

For any bet types, BC reserves the right to restrict the maximum win or place dividend price payable to the following:

- Thoroughbred Racing \$101;
- Harness Racing \$31; and
- Greyhound Racing \$31.

### 6.2. Maximum win amounts

Unless otherwise agreed, the maximum a client can win and/or be paid out via the Internet or phone (on any single bet type) is \$100,000 win / \$50,000 place on Australian metropolitan thoroughbred racing, \$50,000 win / \$25,000 place on Australian non-metropolitan thoroughbred racing and \$25,000 win / \$10,000 place on all Australian greyhound and harness racing. Protest Payout has a maximum payout of \$2000 per client per race.

### 6.3. Minimum Telephone bets for Racing:

\$50 per bet for Thoroughbreds, Harness, and Greyhound racing markets.

### 6.4. Minimum Internet Bets

The minimum bet over the internet is \$1.00, unless having an exotic bet where the minimum is \$0.50 or \$1.00 depending on the type of exotic bet. Note, when using the flexi-bet option, the minimum stake per combination is \$0.01 as well.

### 6.5. Betting.club reserves the right, without exception, to amend the amount of bet winnings paid to a client's account under the following circumstances:

- If a losing bet was paid out incorrectly as a winning bet
- If there are reasonable grounds to suspect that manipulation of tote pools, or any other form of price manipulation has occurred.
- If there are reasonable grounds to suspect that collusion has taken place between a number of clients.

- If the amount of winnings paid into the clients account have exceeded betting.club's Maximum Payout Limits as stated in our Terms and Conditions.

## 7. BET TYPES

### 7.1. Fixed odds win and place

- a. Fixed odds will refer to the price quoted by betting.club of a specified runner at the time of placing the wager for both Win and Place markets. These odds are fixed at the time the wager is placed.
- b. Fixed odds bets placed on "Final Field" win and place markets may be subject to deductions as described under the "Scratching's and Deductions" rule.

### 7.2. Middle tote win and place

- a. Middle Tote Win will guarantee a dividend equal to the second highest official Win dividend declared by the three Australian Totes.
- b. Middle Tote Place will guarantee a dividend equal to the second highest official Place dividend of the three Australian Totes.

### 7.3. Best Tote

- a. 'Best Tote' Win will guarantee a dividend equal to the highest official Win dividend declared by the three Australian Totes.
- b. betting.club reserves the right to restrict the maximum dividend payable on 'Best Tote' to \$101.
- c. 'Best Tote' place will guarantee a dividend equal to the highest official place dividend declared by the three Australian Totes. In the event of a late scratching/s and the field is reduced to 7 runners or less 'Best Tote' place will pay as follows :
  - If all three Australian place totes pay on 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup>, Best Tote place will pay the highest place dividend declared by all three totes.
  - In the event of only two Australian place totes paying 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup>, Best Tote place will pay the highest place dividend declared by only the totes that are officially paying 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> placegetters.

### 7.4. Top fluctuation

- a. Top Fluctuation wagers are guaranteed to be paid at the top fluctuation of the relevant state Official Price (OP).
- b. Top Fluctuation is available up to 45 minutes prior to the advertised start time of the race.
- c. Place portions of an 'Each-Way' Top Fluctuation wager will be paid at Middle Tote.
- d. The maximum stake will be at the discretion of betting.club bookmakers at the time of you placing your bet.

### 7.5. Best Of Best

- a. Best Of Best applies to win betting only, and guarantees that a wager will be paid out at either Top Fluctuation or Best Tote, whichever is greater.
- b. Best Of Best is available up to 40 minutes prior to the advertised start time of the race.

### 7.6. Tote + %

- a. The "+ %" indicates that on top of the specified Tote dividend, there will be an extra percentage of your winnings added to the dividend.

- b. Best Tote +5% will guarantee a dividend equal to the highest official dividend declared by the three Australian Totes, +5% of your winnings on that wager.
  - c. Home Tote +5% will guarantee a dividend equal to the official dividend of the Tote of the state in which the event took place, +5% of your winnings on that wager.
  - d. Home Tote +10% will guarantee a dividend equal to the official dividend of the Tote of the state in which the event took place, +10% of your winnings on that wager.
  - e. Middle Tote +5% will guarantee a dividend equal to the second highest official dividend declared by the three Australian Totes, +5% of your winnings on that wager.
  - f. VIC Tote +5% will guarantee a dividend equal to the dividend declared by Vic Tote, +5% of your winnings on that wager.
- 7.7. Best Tote + SP
- a. Best Tote + SP will guarantee a dividend equal to the highest official dividend declared by the three Australian Totes, or the official on-course starting price, whichever is greater.
- 7.8. Fixed odds with tote guarantees
- a. ("Middle Tote guarantee" or "Fixed+ Mid" for example) guarantees that the dividend on a wager will be either the fixed odds taken at time of the bet, or the second highest official Win dividend declared by the three Australian Totes, whichever is greater.
  - b. ("Best Tote Guarantee" or "Fixed+ Best" for example) guarantees that the dividend on a wager will be either the fixed odds taken at time of the bet, or the highest official Win dividend declared by the three Australian Totes, whichever is greater.
  - c. ("Fixed Plus NSW" or "Fixed+ NSW" for example) guarantees that the dividend on a wager will be either the fixed odds taken at time of the bet, or the official Win dividend declared by the 'NSW Tote', whichever is greater.
  - d. ("Fixed Plus VIC" or "Fixed+ VIC" for example) guarantees that the dividend on a wager will be either the fixed odds taken at the time of the bet, or the official Win dividend declared by 'VIC Tote', whichever is greater.
- 7.9. All-In/futures betting
- a. Prior to Final Field being declared on a race, all bets are accepted on an All-In basis, whereby there will be no refunds for non-runners and no deductions from any other runner.
  - b. Bets placed after the final field is declared are eligible for a full refund on scratched horses, and deductions may apply to any fixed odds bets placed on remaining runners.
  - c. Regardless of whether an All-In event has been postponed or transferred from the original date, all bets will stand until the completion of the event.
  - d. Unless otherwise agreed, \$100,000 will be the maximum payout on any winning 'Futures event/All-In event' on any thoroughbred All-In market per client per event.
  - e. Unless otherwise agreed, \$100,000 will be the maximum payout on any winning Multi 'Futures event/All-In event' on any thoroughbred All-In market per client per event.
- 7.10. Protest Payout
- a. To be eligible for BC Protest Payout your horse must be first past the post and a protest officially placed. The protest must then be upheld and your runner relegated from first to another official placing.
  - b. Protest Payout applies to Australian thoroughbred and harness races.



- c. Protest Payout applies to bets placed on the final field market, future market bets are not eligible for Protest Payout.
- d. Protest Payouts will not apply to exotic bets or multi-bets.
- e. Protest Payout applies to win only bets and the win portion of each way bets.
- f. Protest Payout applies to the first runner past the post, does not apply to place getters.
- g. Protest Payout has a maximum payout of \$2000 per client per race.
- h. All betting.club offers are intended for recreational customers and betting.club may use its discretion to limit the eligibility of customers to participate in all or part of any promotion.

## 8. EXOTIC BET TYPES

### 8.1. When no dividends declared for Exotic bets

Exotic bet types refer to Quinella, Exacta, Trifecta, First Four, Quadrellas and Daily Double bet types. For all Exotic bets relating to Vic Tote only dividends, and in the event that VIC Tote does not declare a dividend on a particular Exotic combination, the following rulings will apply:

- a. If the total amount of winning units held by BC is equal or greater than 1.00 unit, then the declared dividend will be the total amount of the Vic Tote pool divided by the total amount of winning combinations held by BC on the event. For example, BC holds 1.6 total winning units on the market, and the total amount of the pool is \$1,000. In this Case the dividend declared would be \$625 ( $\$1,000 \div 1.6 = \$625$ ).
- b. If the total amount of winning bets held by BC is less than 1.00 unit, then the declared dividend will be the total dollar amount of the Vic Tote pool. For example, BC holds 0.4 winning units on the market, and the total amount of the pool is \$1,000. In this Case the dividend declared would be \$1,000 (i.e. the total pool amount).
- c. In either "a" or "b" above, the amount paid to a client will be calculated based upon multiplying the dividend by the percentage of a 1.00 unit held by that client.

### 8.2. Quinella

- a. A Quinella requires nominating the 1st and 2nd place-getters in any order.
- b. Quinella bets on all Australian and International thoroughbred, harness and greyhound markets will be paid at the official VIC Tote dividend.
- c. In the event of a Dead-Heat there will be as many dividends paid out as there are correct order combinations as declared by the VIC Tote.
- d. In the event of a scratching or a runner being declared a non-runner after a wager is placed, the relevant portion of that wager will be refunded to the clients account.
- e. All Quinella wagers relating to VIC Tote only dividends are subject to rule 1.7 under General Racing Rules.
- f. Unless otherwise agreed, \$10,000 will be the maximum payout on any winning 'Quinella' on metropolitan and non-metropolitan greyhound & harness meetings per client per event.
- g. Unless otherwise agreed, \$25,000 will be the maximum payout on any winning 'Quinella' on metropolitan and non- metropolitan thoroughbred meetings per client per event.

### 8.3. Exacta

- a. An Exacta requires nominating the 1st and 2nd place-getters in correct order.

- b. A Box Exacta requires you to select two or more runners from which any two can finish 1<sup>st</sup> and 2<sup>nd</sup>, in any order.
- c. Exacta bets on all Australian and International thoroughbred, harness and greyhound markets will be paid at the official VIC Tote dividend.
- d. In the event of a Dead-Heat there will be as many dividends paid out as there are correct order combinations as declared by VIC Tote.
- e. In the event of a scratching or a runner being declared a non-runner after a wager is placed, the relevant portion of that wager will be refunded to the clients account.
- f. All Exacta wagers relating to VIC Tote only dividends are subject to rule 10.8 under General Rules.
- g. Unless otherwise agreed, \$10,000 will be the maximum payout on any winning 'Exacta' on metropolitan and non-metropolitan greyhound & harness meetings per client per event.
- h. Unless otherwise agreed, \$25,000 will be the maximum payout on any winning 'Exacta' on metropolitan and non-metropolitan thoroughbred meetings per client per event.

#### 8.4. Trifecta

- a. A Trifecta requires nominating the 1st, 2nd and 3rd place-getters in correct order.
- b. A Box Trifecta requires you to select three or more runners, from which any three can finish 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> in any order.
- c. Trifecta bets on all Australian and International thoroughbred, harness and greyhound markets will be paid at the official VIC Tote dividend.
- d. In the event of a Dead-Heat there will be as many dividends paid out as there are correct order combinations as declared by VIC Tote.
- e. In the event of a scratching or a runner being declared a non-runner after a wager is placed, the relevant portion of that wager will be refunded to the clients account.
- f. All Trifecta wagers relating to VIC Tote only dividends are subject to rule 1.7 under General Racing Rules.
- g. Unless otherwise agreed, \$10,000 will be the maximum payout on any winning 'Trifecta' on metropolitan and non-metropolitan greyhound & harness meetings per client per event.
- h. Unless otherwise agreed, \$25,000 will be the maximum payout on any winning 'Trifecta' on metropolitan and non-metropolitan thoroughbred meetings and on metropolitan thoroughbred meetings per client per event.

#### 8.5. First Four

- a. A First Four requires nominating the 1st, 2nd, 3rd and 4th place-getters in correct order.
- b. A Box First Four requires you to select four or more runners from which any four can finish 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> in any order.
- c. First Four bets on all Australian and International thoroughbred, harness and greyhound markets will be paid at the official VIC Tote dividend.
- d. In the event of a Dead-Heat there will be as many dividends paid out as there are correct order combinations as declared by VIC Tote.
- e. In the event of a scratching or a runner being declared a non-runner after a wager is placed, the relevant portion of that wager will be refunded to the clients account.

- f. All First Four wagers relating to VIC Tote only dividends are subject to rule 1.7 under General Racing Rules.
- g. Unless otherwise agreed, \$10,000 will be the maximum payout on any winning 'First Four' on metropolitan and non-metropolitan greyhound & harness meetings per client per event.
- h. Unless otherwise agreed, \$25,000 will be the maximum payout on any winning 'First Four' on metropolitan and non-metropolitan thoroughbred meetings per client per event.

## 8.6. Quadrella

- a. A Quadrella requires nominating the 1st place runner in four races of a meeting as specified by betting.club.
- b. Quadrella bets will be paid at the official VIC Tote dividend.
- c. In the event of a Dead-Heat there will be as many dividends paid out as there are correct order combinations as declared by VIC Tote.
- d. In the event of a scratching or a runner being declared a non-runner after a wager is placed, that portion of the wager will be transferred to the substitute favourite as declared by betting.club.
- e. All Quadrella wagers relating to VIC Tote only dividends are subject to rule 1.7 under General Racing Rules.
- f. Unless otherwise agreed, \$10,000 will be the maximum payout on any winning 'Quadrella' on metropolitan and non-metropolitan greyhound & harness meetings per client per event.
- g. Unless otherwise agreed, \$25,000 will be the maximum payout on any winning 'Quadrella' on metropolitan and non-metropolitan thoroughbred meetings per client per event.

## 8.7. Daily Double

- a. A Daily Double requires nominating the winner of two selected races of a meeting as specified by betting.club.
- b. Daily Doubles will be paid at the official VIC Tote dividend.
- c. In the event of a Dead-Heat there will be as many dividends paid out as there are correct order combinations as declared by VIC Tote.
- d. In the event of a scratching or a runner being declared a non-runner after a wager is placed, that portion of the wager will be transferred to the substitute favourite as declared by betting.club.
- e. All Daily Double wagers relating to VIC Tote only dividends are subject to rule 1.7 under General Racing Rules.
- f. Unless otherwise agreed, \$10,000 will be the maximum payout on any winning 'Daily Double' on metropolitan and non-metropolitan greyhound & harness meetings per client per event.
- g. Unless otherwise agreed, \$25,000 will be the maximum payout on any winning 'Daily Double' on metropolitan and non-metropolitan thoroughbred meetings per client per event.

## 8.8. Place Card

- a. A Place Card requires you to correctly select a horse to place in four races as nominated by betting.club.

- b. The total dividend is calculated by adding the place prices quoted at the time the wager is placed.
- c. In races where there are 8 runners or more, horses that run 1st, 2nd or 3rd are deemed to have placed.
- d. In races where there are 5, 6 or 7 runners, horses that have run 1st or 2nd are deemed to have placed.
- e. In races where there are 4 runners or less, only horses that run 1st are deemed to have placed.
- f. Where there is a late scratching in a Place Card leg and the number of runners is reduced to 7 or less, the above rules will apply for and wagers placed after the late scratching.
- g. For wagers placed on a field of 8 or more prior to the late scratching, horses that run 1st, 2nd and 3rd are deemed to have placed.
- h. If the selection(s) on any leg of the Place Card are scratched and there are no selections on that leg then the wager will become a 3 leg Place Card.
- i. If the selections(s) on any 2 legs of the Place Card are scratched and there are no selections on either of the two legs, then the Place Card wager will be voided and monies will be refunded.
- j. If 1 leg of the Place Card is abandoned or declared a no race, then it will revert to a 3 leg Place Card.
- k. If 2 or more legs of a Place card are abandoned or declared a no race, then all bets on the Place Card are deemed void and monies will be refunded.
- l. In the Case of a Dead-Heat for 3rd by two or more runners in any leg of the Place Card, the Dead-Heat rule will be applied.
- m. Unless otherwise agreed, \$20,000 will be the maximum payout on any winning 'Place Card' on all thoroughbred meetings per client per event.

## 8.9. Flexi Betting

- a. betting.club offers Flexi betting on all exotic bet types. Flexi betting allows you to specify the amount you would like to invest on particular exotic combinations.
- b. The total amount wagered on each combination covered on a Flexi bet is determined by dividing the total amount of the Flexi bet by the number of combinations covered by the Flexi bet.
- c. Boxing Exotics refers to selecting multiple runners in an exotic bet which must fill the event placing's in any order for the wager to be successful.

## 8.10. Multi-Bets/All-Ups

- a. For the Multi wager type, if any leg/legs that form part of a Multi bet are void, the Multi bet will be recalculated excluding the voided leg/legs. Multis/All-Ups
- b. The maximum number of legs allowed for a Racing Multi with BC is 8 legs.
- c. Unless otherwise agreed, \$40,000 will be the maximum payout on any winning 'Multi' on Thoroughbred, greyhound & harness meetings per client per event, excluding Head to Head bet types.

## 8.11. Head to Head

- a. Head to Head betting will be available on selected races. Bets will be settled on the highest finishing position.

- b. All selections included in a Head to Head market must start or all bets on that market will be voided and monies refunded. "Dead-Heat" rules apply to all Head to Head betting markets.
- c. In the event of a protest, bets will be paid out on the official final placing's of the race.
- d. Unless otherwise agreed, \$10,000 will be the maximum payout on any winning 'Head to Head' on all Australian thoroughbred race meetings per client per event.
- e. Unless otherwise agreed, \$5,000 will be the maximum payout on any winning 'Head to Head' on all greyhound & harness meetings per client per event.
- f. 'Head to Head' Multi-Bets will be a maximum payout of \$20,000 on all thoroughbred race meetings per client per event, and a maximum of \$10,000 on all greyhound and harness meetings per client per event.

## 8.12. Jockey Challenge

- a. Jockey Challenge Points are awarded on a 3-2-1 points system. 1st = 3 points, 2nd = 2 points, 3rd = 1 point. The jockey who accumulates the most points is declared the winner.
- b. In the Case of two or more jockeys finishing on the same amount of points, the "Dead-Heat" rule will apply regardless of the number of winning rides a particular jockey may have completed.
- c. If all or part of a meeting is postponed or abandoned, and there is no unassailable winner then all Jockey Challenge wagers will be voided and monies refunded however if there is an unassailable winner then all Jockey Challenge bets will stand.
- d. If 2 or more runner's Dead-Heat for 1st, 2nd or 3rd in a race, then the points will be shared equally amongst the relevant jockeys.
- e. All listed jockeys must complete at least 1 ride for Jockey Challenge bets to stand. If a listed jockey does not complete at least 1 ride then ALL Jockey Challenge bets are voided.
- f. Unless otherwise agreed, \$10,000 will be the maximum payout on any winning Jockey Challenge wager on all Australian thoroughbred race meetings per client per event. 'Jockey Challenge' Multi-Bets will be a maximum payout of \$20,000 on all thoroughbred race meetings per client per event.
